

Niveles de Certificación en TFP

Nivel A - Estudiante:

Participación en cursos, seminarios o talleres sin continuar con la supervisión.

Se otorga un documento que especifica el tema, el profesor(es) y las horas de formación.

Nivel B - Terapeuta Didáctico de TFP:

Completar un plan de estudios con al menos 42 horas de seminarios.

Presentar aplicaciones prácticas de TFP en supervisión o mediante casos en video.

Recibir un documento de finalización de formación.

Nivel C - Terapeuta de TFP:

Completar un total de 63 horas de seminarios adicionales (nivel B + C).

Realizar supervisión continua de TFP durante al menos 2 años con presentaciones mensuales de casos de formación (al menos 20 horas de supervisión en total).

Contar con 2 supervisores en secuencia, con la posibilidad de solicitar una excepción en casos excepcionales.

Nivel D - Terapeuta de Estudio de TFP:

Cumplir con las calificaciones necesarias según el diseño del estudio.

Obtener aprobación del Comité de Investigación y Publicación de ISTFP.

Nivel E - Profesor y Supervisor de TFP:

Después de alcanzar el nivel C, se puede solicitar iniciar el camino para convertirse en Profesor y Supervisor de TFP o ser propuesto por el instituto local o supervisor anterior.

Cumplir con los requisitos: supervisión continua de TFP durante al menos 2 años con presentaciones mensuales de otro caso de formación (mínimo 20 horas de presentaciones).

Contar con experiencia en enseñanza y co-supervisión de TFP.

Para el examen de nivel E:

Presentar un nuevo caso en video.

Supervisar el caso de otro candidato, demostrando habilidades teóricas y técnicas.

Recibir el certificado de Profesor y Supervisor de TFP del Comité de Formación y Educación de ISTFP.

Notas:

La co-supervisión implica trabajar conjuntamente con un Profesor y Supervisor de TFP y puede realizarse dentro de un grupo de supervisión.

Los detalles sobre co-supervisión y co-enseñanza se discutirán con el supervisor.

E	TFP teacher and supervisor	<p>After achieving level C:</p> <p>1) Applications to start the pathway to become T&S may be made by the candidate (see note), or may be proposed by the local institute (if recognized by the ISTFP) or the previous supervisor. Support from supervisors is necessary.</p> <p>Admission will be evaluated by a group discussion between the supervisor(s), the local institute and/or T&E committee. Notes

Application for supervisor-trainer: the candidate writes a short paragraph describing why he/she thinks would be a good candidate

Co-supervision:

1. One year of at least monthly continuous co-supervision with a T&S, as a member of an existing supervision group, with regular involvement in the process as a Co-supervisor
2. If more than one candidate in a group, co-supervisor should take the lead of the supervision at least monthly (or for a longer period of time), in rotation with the other co-supervisors. If co-supervision cannot be done monthly, it will take longer time, e.g. 2 years.
3. Specific arrangements for co-supervision will be discussed with the supervisor: frequency, organization of the supervision, etc.
4. Example of co-supervision (1 hour – 1,5 hours):
 1. supervisions lasts 1 hour and a half in case of consecutive translation (very time consuming).
 2. transcription: it starts with brief updating of what happened inside and outside treatment since last supervision, goals and psychodynamic hypotheses, major difficulties, transference and countertransference issues; this is useful because it's a question we always make and so it's time saving to have it already written.
 3. for 30 (50) minutes the candidate-supervisor conducts the supervision with the therapist; time limit is useful to stimulate a priority of questions, comments, and suggestions to the therapist; it should protect from the risk of focusing on details and missing the big picture of what's going on.
T&S doesn't intervene in this phase.
 4. for 20 (30) minutes T&S makes comments and questions mostly to the candidate-supervisor but also to the therapist.
 5. for 10 minutes comments from the group. This is a very short time and there is almost no possibility for analyzing parallel processes but consecutive translation doubles the time of every comment.

Co-teaching, examples:

1. A junior teacher will accompany a senior teacher in TFP curriculum. Part of the teaching will be on the side of the candidate. If two or more candidates, different topics could be taught by different candidates.
2. Co-teaching in seminars with T&S.
3. In cases where it is not possible to participate in a formal curriculum, co-teaching experience could be arranged within the supervision group. Specific arrangements for co-teaching will be discussed with the supervisor.

[1] The ISTFP Board of Supervisors will be constituted from all certified TFP supervisors. ISTFP members, who are already teachers and supervisors will automatically become members of the Board.
